The Swap was discussed with members giving their impressions of the swap. This year the attendance wasn't as good as expected. No decision was made on whether or not to continue. Possibilities of combining with other clubs was discussed and will be explored.

The annual picnic was a success with an abundance of food with brats and hotdogs grilled to perfection by Denny, KC8UWC. There were 19 in attendance. It was mention that the picnic in August and the one at Field day have been well received by making it a family affair.

The liability insurance policy was discussed and it was pointed out that \$111.00 of the premium was just a minimum premium adjustment. We will contact Alpena Agency to see if we can purchase some more coverage with that amount. Last year we increased the coverage from \$1,000,000 to \$2,000,000 to try to get better coverage.

The establishing of a Memorial Fund was discussed and approved on a motion by Joe, KD8VLY, seconded by Jim, WB8OR.

The funding of Memorial Fund was approved by donations collected by Jerry, W8KQ, on a motion by Joe, KD8VLY.

A presentation on 2 meter simplex operation was made. The 2 meter band plan was reviewed and the simplex channels pointed out. FM signal reporting was review. We will have a 2 meter simplex net on Mondays after the regular net on the repeater. The simplex net will be on 146.52 MHz and the purpose is to map out the 2 meter simplex coverage in the Alpena area.
