The September meeting minutes were handed out and approved on a motion by Wayne, K8QBZ, seconded by. Denny, KC8UWC

Hugh, wq8tv, reported that after contacting two other insurance agencies, the current insurance through the Alpena Agency is the best for the club. There were some questions as to what is covered by the Lability policy and there will be an update next month. It turns out that a non-profit is difficult organization to cover by Liability issues. A addition to the Constitution may need to be amended to specify what actives are covered by the liability policy. Equipment insurance was also discussed and will be clarified at a later meeting.

A discussion was held on how to get younger people involved in Ham radio. An ARRL Kids Day Flyer was handed out.

Bob, WB8ZIQ, brought his lightening detector to show and explained how it performed. He said that it was a simple circuit that could easily be made.

Doug, WD8Z, reviewed the antenna outing that we had at the Fair ground last Saturday. A quarter wave wire cut for 3800 KHz was hung from a tree at ~40 feet in an "inverted L" configuration. Two ground plane radials the same length were suspended at the same level as the feed point at right angles to the "inverted L". The SWR was less than 2:1 and a good contact was made with a ham in Flint. And also were able to hear a VE2 station but he had a problem hearing us. The 2 meter simplex test was discussed – a comparison to 10 meter was suggested and 10 meter antennas were also discussed. Wayne, K8QBZ, will be starting a 10m net on 28.450 MHz on Mondays after the 2m net.
