a. It was suggested that other clubs be contacted to see what equipment and protocols they use.
- c. Wayne K8QBZ requested help in moving our equipment out of the EOC room by Oct.1st as the EOC has need of that room. New location for the equipment is yet to be determined. Wayne K8QBZ, Don W8DGS, Dick W1UP, Hugh WQ8TV. Peter KM4CTD, and Mike KE8FSR volunteered to help.
- d. Wayne K8QBZ also reported that if TBARC wants to continue to be involved in Emergency Services members need to be trained and participate, At least 6 hams are needed. Wayne K8QBZ, Hugh WQ8TV, Don W8DGS, Davin KE8RDV, Peter KM4CTD and Mike KE8FSR stated they are willing to be trained.
